MOST IMPORTANT ANNOUNCEMENTS DURING Q2 2022

Kemira upgrades its 2022 outlook for operative EBITDA

<u>June 8, 2022</u>, Kemira upgraded its outlook for operative EBITDA. Kemira expects operative EBITDA to increase from 2021 (EUR 425.5 million). Previously Kemira expected its operative EBITDA to be within a +/- 5% range of the operative EBITDA in 2021. Kemira's outlook for revenue is unchanged.

May 18, 2022, President, Segment Pulp & Paper Kim Poulsen left Kemira on Wednesday May 18, 2022. The search for a successor is ongoing.

Kemira to exit Russian market Kemira exits Russian market and closes local operations May 6, 2022, Kemira announced a decision to discontinue deliveries to Russia and Belarus on March 1, 2022 due to the Russian military attack in Ukraine. Kemira is in the process of closing down remaining operations in Russia.

Kemira and Danimer Scientific expand exclusive partnership to commercialize fully biobased barrier coatings

May 3, 2022, New multi-year license and supply agreement builds on successful joint development of biobased coatings for paper and board products using sustainable biopolymer.

Kemira's EcoVadis sustainability rating again Platinum level - Kemira among the top 1% of companies in the world

On April 25 2022, Kemira has again been awarded the Platinum level rating by the global sustainability rating platform EcoVadis. The total score improved to 78 out of 100 (73/100 in 2021) putting Kemira among the top 1% of companies in the world.

FREQUENTLY ASKED QUESTIONS DURING THE QUARTER

What were the main reasons behind upgraded guidance?

Kemira has had a good start to the year. Kemira's end-market demand has continued to be good and Kemira expects the demand to remain good for the rest of 2022. The strong inflationary environment has continued, but Kemira has taken successful actions to mitigate the impact. Kemira started the mitigation actions already in early 2021.

Was Kemira impacted by the stoppage of Russian gas to Finland?

Kemira does not really use natural gas in its facilities in Finland. In certain sites in Finland, we use liquified natural gas. Overall, there has been no real direct impact after Russia stopped gas deliveries to Finland. It could have an impact on Kemira indirectly via customers and suppliers, but so far impact has been limited.

How is Kemira prepared for possible natural gas disruptions in Europe?

Some of Kemira's facilities in Continental Europe use natural gas and the share of Russian gas varies by facility. Only a few of our European sites use natural gas in production, mostly gas is used for heat and steam. We are in active discussions with local authorities should there be gas shortages, and we are preparing for various scenarios. The largest impact of possible gas shortages is expected to come via Kemira's customers and suppliers.

INVESTOR ACTIVITIES AND EVENTS DURING Q2 2022

Kemira had physical investor roadshows in London, Brussels and the Netherlands, one virtual group meeting for Helsinki based investors and individual calls with US-based investors during Q2 2022. In June, Kemira organized a site visit together with Metsä Board to Simpele and Joutseno for the

companies' sell-side analysts. In addition, Kemira hosted a visit to its Espoo R&D Center and also hosted a pre-silent lunch and call for sell-side analysts following Kemira in June.
